Comments: AS(15MF/3) is a mefloquine-resistant clone, derived by treatment of chloroquine-resistant mutant AS(15CQ) with increasing doses of mefloquine over 24 mouse passages and transmission through *Anopheles stephensi*.

History:

Original thicket-rat (Thamnomys rutilans) AS (399BY) containing *P. c. chabaudi* trapped by Y. Boulard, sent to Paris, France, then Edinburgh (1969). Isolate AS passaged in mice. Clone AS(15MF/3) produced in Edinburgh by mefloquine treatment of chloroquine-resistant mutant *P. c. chabaudi* AS(15CQ).

Amplification:

Cryopreserved material should be injected in mice via the i.p. route. To maintain the strain in vivo, passage infected blood from donor to recipient mice via the i.v. route.

Cryopreservation:

Deep freeze solution: 28% glycerol, 3% sorbitol, 0.65% NaCl. Added as equal volume to that of the whole infected blood. 0.2ml (approximately) aliquots placed in ampules with parasitemia of 10%. Slow freeze to -80C overnight and transfer to vapor phase N2 or flash freeze in liquid N2.
