Antibody Class: IgG1ĸ

Mouse monoclonal antibody prepared against the light chain of subtype A1 neurotoxin of *Clostridium botulinum* (*C. botulinum*) was purified from clone L9B12.2 hybridoma supernatant by protein G affinity chromatography. The B cell hybridoma was generated by the fusion of NSO mouse myeloma cells with splenocytes from mice immunized by intraperitoneal and intravenous injection with recombinant *C. botulinum* neurotoxin subtype A1 (BoNT/A1) light chain.¹

C. botulinum are anaerobic Gram positive spore-forming bacteria which produce neurotoxins categorized serologically into seven types, A thorough G.² Four of the seven serotypes cause human botulism with the vast majority of cases due to serotypes A and B.³ BoNT/A1 is a zinc-binding metalloprotease (holotoxin) that is endogenously cleaved into a heavy (~ 100 kDa) and a light chain (~ 50 kDa) that are held together by a reducible disulfide bond.⁴

Material Provided:

Each vial of NR-20812 contains approximately 100 μL of purified monoclonal antibody in PBS. The concentration, expressed as mg per mL, is shown on the Certificate of Analysis.

Packaging/Storage:

NR-20812 was packaged aseptically in screw-capped plastic vials and is provided frozen on dry ice. The product should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be avoided.

Functional Activity:

NR-20812 reacts with the light chain of botulinum neurotoxin type A in western blot assays. The antibody is also reported to be useful for ELISA, RIA, flow cytometry, immunocytochemistry, immunohistochemistry, and immunoprecipitation.
