**Product Description:**

Complementary DNA (cDNA) was synthesized from RNA extracted from *Biomphalaria glabrata* (*B. glabrata*), strain BS-90.

*B. glabrata*, strain BS-90 is a pigmented laboratory maintained strain which was derived from field isolates in Brazil in the 1960s.<sup>1</sup> Strain BS-90 is known to be resistant to infection by *Schistosoma mansoni* (*S. mansoni*). *S. mansoni* is a species of trematode worm which causes the chronic parasitic disease Schistosomiasis.

**Material Provided:**

Each vial of NR-44212 contains approximately 0.5 µg of cDNA in DNase/RNase-free distilled water. The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

**Packaging/Storage:**

NR-44212 was packaged in cryovials. The product is provided frozen and should be stored at -20°C or colder upon arrival. Freeze-thaw cycles should be minimized.
