Product Description:

Antiserum to P35 surface antigen GRA8 of *Toxoplasma gondii* was produced by intradermal immunization of a female three month old New Zealand white rabbit with two P35 surface antigen GRA8 peptides conjugated to keyhole limpet hemocyanin (KLH).

Material Provided:

NR-4930 is distributed as a three vial kit. The kit contains pre-bleed (NRC-1031), first bleed (NRC-1032) and second bleed (NRC-1033) rabbit polyclonal antiserum. Each vial contains approximately 0.19 mL (pre-bleed) or 0.800 mL (first and second bleed) of rabbit polyclonal antiserum.

NR-4930 is reactive with P35 surface antigen GRA8 of *Toxoplasma gondii* by ELISA, immunofluorescence and Western blot analysis as communicated by the contributor.
