Antibody Class: IgG1k

Mouse monoclonal antibody reactive with the nucleoprotein of Junin virus¹ was purified from mouse ascites by protein A affinity chromatography.

Material Provided:

Each vial of NR-2573 contains approximately 1 mg of purified monoclonal antibody in 0.02 M potassium phosphate buffer (pH 7.2) containing 0.15 M sodium chloride and 0.02% (w/v) sodium azide. The concentration, expressed as mg per mL, is shown on the Certificate of Analysis.

Packaging/Storage:

NR-2573 was packaged aseptically in glass serum vials and is provided frozen. NR-2573 may be stored undiluted at 4°C for several weeks. It should not be diluted until immediately prior to use. For long-term storage, NR-2573 should be aliquoted and stored at -20°C or colder. Freeze-thaw cycles should be avoided.
