## **Product Description:**

Genomic DNA was extracted from a preparation of *Candida albicans (C. albicans)*, strain 23Q.

C. albicans, strain 23Q is a human isolate collected in China.1

NR-50389 has been qualified for PCR applications by amplification of approximately 1200 base pairs of ribosomal RNA and internal transcribed spacer (ITS) region.

#### **Material Provided:**

Each vial contains fungal genomic DNA in buffer. The amount per vial, concentration and buffer composition are shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

# Packaging/Storage:

NR-50389 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival. For long-term storage, the product should be stored at -80°C. Freeze-thaw cycles should be minimized.
