Original Source: Influenza B virus, B/Brisbane/60/2008 (Victoria Lineage) was isolated from a human in Queensland, Australia on August 4, 2008.

Comments: The US Food and Drug Administration recommended influenza B/Brisbane/60/2008-like viruses for use as vaccines during the 2009-2010, 2010-2011, and 2011-2012 influenza seasons. The World Health Organization recommended influenza B/Brisbane/60/2008-like viruses for use as vaccines during the 2009-2010, 2010-2011, and 2011-2012 Northern Hemisphere, and the 2010, 2011, and 2012 Southern Hemisphere influenza seasons. Sequence information is available for influenza B virus, B/Brisbane/60/2008 (Victoria Lineage) at the Influenza Research Database.

#### **Material Provided:**

Each vial contains approximately 1 mL of pooled allantoic fluid from specific pathogen free (SPF) embryonated chicken eggs infected with influenza B virus, B/Brisbane/60/2008 (Victoria Lineage).

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

#### Packaging/Storage:

NR-42005 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

#### **Growth Conditions:**

<u>Host</u>: 9- to 11-day-old SPF embryonated chicken eggs <u>Infection</u>: Embryonated chicken eggs must be candled to confirm viability prior to inoculation

Incubation: 3 days at 35°C in a humidified chamber

<u>Effect</u>: Hemagglutination activity using allantoic fluid from infected embryonated chicken eggs and chicken red blood cells
