### Product Description:

HRP-20096 is a full-length, infectious molecular clone of the simian immunodeficiency virus (SIV), SIVsmE660-807-16w Env which is available through NIH HIV Reagent Program (HRP-20121).<sup>1,2,3</sup> SIVsmE660-807-16w Env is a chimeric variant of SIVsmE660-FL14 (HRP-20120; GenBank: [JQ864087.1](#)) encoding envelope glycoprotein gene (GenBank: [JQ864161](#)) cloned at 16 weeks following infection of an FL14-inoculated macaque and exhibits Tier 2 moderate neutralization antibody resistance.<sup>1,2</sup> The plasmid encodes full-length, replication-competent virus in a pUC19 vector backbone. The beta-lactamase gene, *bla*, provides transformant selection through ampicillin resistance in *Escherichia coli* (*E. coli*). The pSIVsmE660-807-16w Env insert is approximately 10,300 base pairs and the resulting size of the plasmid is approximately 13,000 base pairs. The insert sequence is provided on the NIH HIV Reagent Program webpage.

### Material Provided:

Each vial contains plasmid DNA in TE buffer (10 mM Tris-HCl, 1 mM EDTA). The DNA concentration and volume provided are shown on the Certificate of Analysis. The vial should be centrifuged prior to opening. **Note:** The contents of the vial should be used to transform the plasmid in *E. coli* prior to mammalian expression.

### Packaging/Storage:

HRP-20096 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -80°C or colder immediately upon arrival. Freeze-thaw cycles should be avoided.
