Product Description:

Plasmodium berghei (P. berghei), strain (ANKA) 354cl4 is a genetically modified clone of the ANKA strain following stable transfection with the pL0028 vector (BEI Resources MRA-797). This line expresses green fluorescent protein (GFP)-luciferase under the control of the *ama-1* promoter and contains the pyrimethamine-resistant form of the *Toxoplasma gondii dhfr-ts* gene as a drug-selectable marker. MRA-866 was produced by inoculation of seed material into 3 ND4 Swiss Webster mice. Infection was allowed to progress for 3 days. Infected blood was collected by orbital bleeding and used to inoculate 22 ND4 Swiss Webster mice. Infection was allowed to progress until parasitemia reached > 5%. After 6 days, infected blood was collected by orbital bleeding.
